

What is Child Protection?

Child protection is the process of protecting children and young people who have been identified as suffering, or likely to suffer harm as a result of abuse.

There are four types of abuse:

Physical
Sexual
Emotional
Neglect

Safeguarding is the action that people take to keep all children safe, for example:

- Protect children from harm
- Ensure that they are safe and well looked after
- Take action so that all children are able to grow up in a safe environment.



ALL CHILDREN HAVE A RIGHT TO BE PROTECTED FROM HARM

What does your school have to do?

At Newton Tony Primary school, our Head Teacher, **Miss Sheena Priestley**, is responsible for child protection. She has the title of **Designated Safeguarding Lead**.

Our school has a Child Protection Policy. This document sets out the process for dealing with child protection concerns. If you would like to read this policy you may find it on our school website. Alternatively the school can provide you with a copy; please ask at our school reception.

This policy also sets out the process for reporting allegations about members of staff, including volunteers.

All adults in our school, including volunteers, must have regular training to ensure that they are aware of the signs of abuse and know what to do about their concerns. They have a duty to report these to the Designated Safeguarding Lead.

Our school has a legal duty to talk to other agencies such as Children's Social Care and the Police if they think a child may be at risk of harm.

THE WELFARE OF YOUR CHILD IS OF PARAMOUNT IMPORTANCE

What do you need to know?



If anyone in our school is worried about the welfare of your child this will be discussed with you unless they think that this conversation could put your child at a greater risk of harm.

Our school must also share all relevant information with Children's Social Care if they are concerned about your child.

The social worker may consult with other agencies before deciding what should happen next. They will also speak to you about the concern and keep you informed about what is happening.

If there is an allegation about an adult who works at our school, the school will hold discussions with the Police and Children's Social Care. If your child is involved, you will be kept informed of any discussions and decisions as appropriate.
